All elements will be tested: Containers/Exterior/Vehicles/Interior (2 spaces for level 2 & 3) There are 5 steps into the building and 12 steps to exit. The elements will be run in succession, one after the other.

- Site opens and check-in at 8:30 a.m.
  - Level 1 Walk thru starts at 9:00
  - Level 2 and Level 3 walk thru times will be determined based on the number of entries and will be communicated at least one week prior to the event.
- Entry fee is \$35 per dog

Dogs must be able to crate quietly in a vehicle out of owner's sight when not working. Any "spatially-challenged" dog must wear a red bandana. Please keep dogs a safe distance from one another.

**Please leave dogs not trialing at home.**

**Parking lot etiquette that is required at trials is in effect. Please know the rules found on the NACSW website.**

We reserve the right to ask a dog/handler team to leave without refund if we feel s/he is inappropriate or dangerous to the other participants.

You may video or photograph your own searches.

Hides will not be reset and may not be blind for the handler if two dogs are run on the same level.

If you have a female in season, please make it known at the Registration table in the morning.

Also, be considerate to give all dogs space when parking and moving around, especially our red bandana dogs. **Dogs not trialing should be left at home.** NACSW parking lot etiquette rules apply.

You will need to be able to navigate various terrain but the path is level. There are five steps into the Interior search area and 12 to exit.
